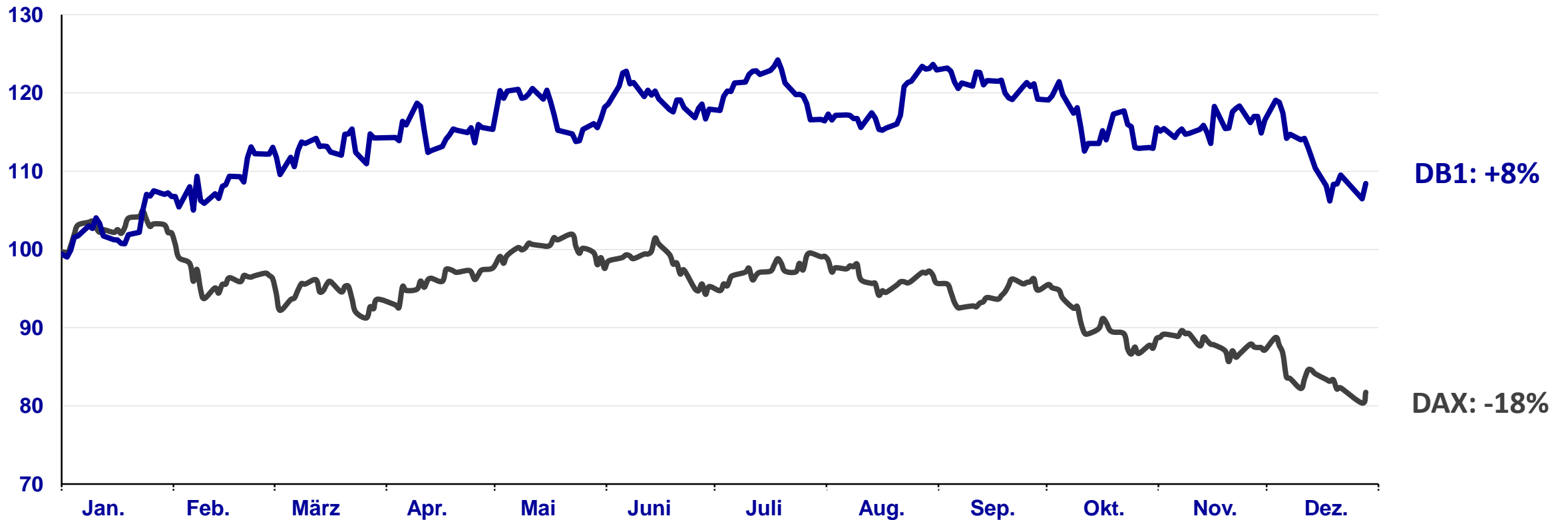

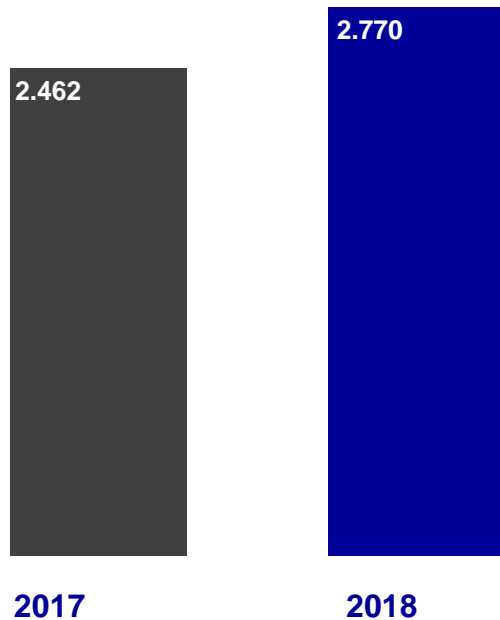

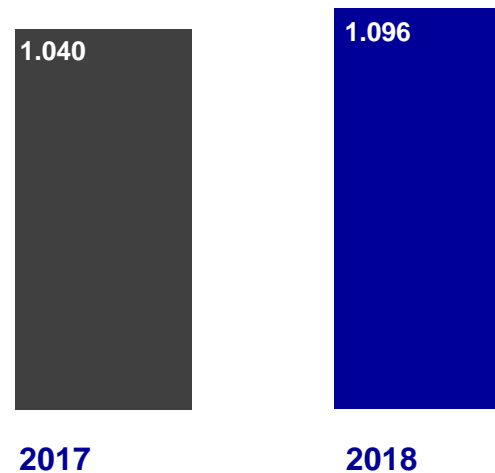

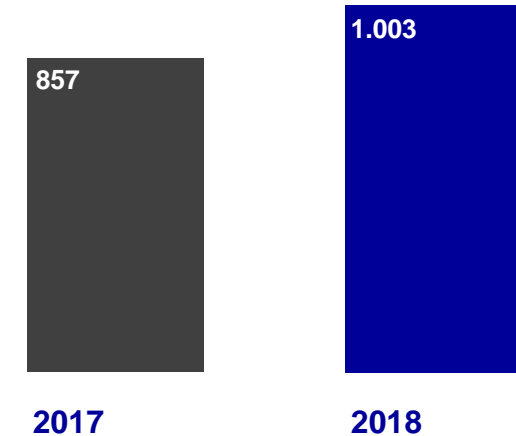

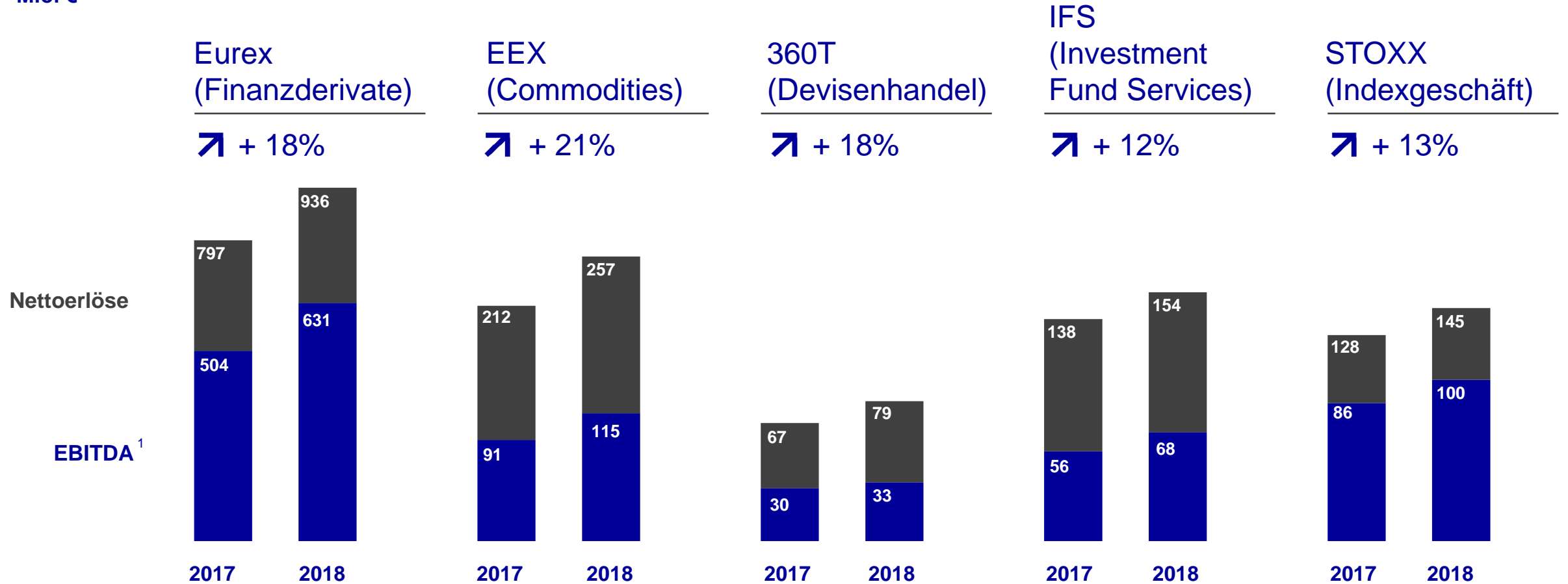

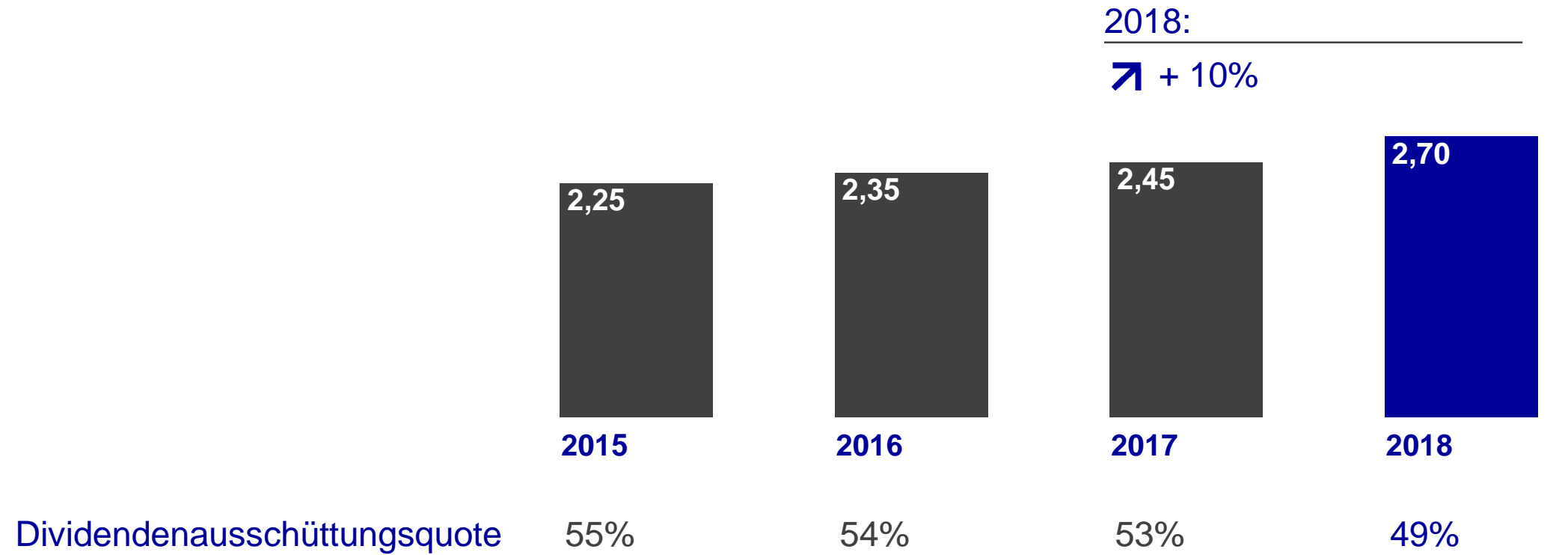
Entwicklung der Wachstumsbereiche
